

## President's Message



1996 will be a challenging year on the westside.

- The Montañño Bridge is under construction, but Los Ranchos still has an appeal pending before the State Supreme Court.
- The City Planning Department has adopted a policy of encouraging urban densities on the westside. This means that City planners are supporting the rezoning of R1 residential lots to SU for apartments and townhouses. They support densities of over 20 dwellings per acre, rather than densities of 2-5 dwellings per acre. By doing this they hope to increase the use of public transportation, prevent urban sprawl, and promote infill within the city borders. If you are concerned about the effects of this policy on our schools, roads, and quality of life, contact Councilor Armijo and Mayor Chavez.
- Planners for the Albuquerque Public Schools are of the opinion that the westside is experiencing steady growth, rather than a boom, and so do not foresee the need for a new westside middle school in the immediate future.
- Construction of the final phase of the Mariposa Basin Park is being held up while groups supporting little league and soccer attempt to redesign the park to devote more space to their sports.
- State funding for our new community center may result from the current State Legislature session, or it may be a casualty of tight budgets.
- Many of our medians are ugly.
- Graffiti continues to be a problem.

Would you like to work these issues (or others) on behalf of yourself and your neighbors? Call Dave Otto (897-7733) and volunteer to run for the Board of Directors of the TRNA. You must be a member of the association, be willing to serve a two year term, be able to attend one board meeting a month, and be willing to work to improve the quality of life in Taylor Ranch. Elections will be held at our General Meeting on March 26th, place TBD.

## Eye on Education

On February 6, 1996, there will be a General Obligations Bond and Mil Levy Election. In 1993, voters approved a two-mil levy for a three-year period, which runs out during the 1995-96 school year. Voters

also approved a General Obligations Bonds issue. This election will be a chance for voters to approve the issuance of an additional \$67.5 million of General Obligations Bonds and to continue the two-mil levy for another three years. Each school will have a list of how the schools in our community will benefit from the passage of the bonds and mil levy.

Although voters approved a two-mil levy in 1993, the residential levy was reduced this year to 1.72 mils or about \$1.72 per thousand dollars of net taxable value due to reappraisal of property at a rate exceeding the rate of inflation. Re-approval of the levy back to two mils or \$2.00 per thousand dollars of taxable value will mean an increase of 28 cents per thousand dollars of taxable value. In real terms, the impact on a home with a value of \$100,000 (taxable value of \$33,333) will be 76 cents per month.

TRNA Education Committee urges your support and a YES vote on the bonds and mil levy on February 6th. Cast your ballot at Marie Huges Elementary School on February 6th, or at Chamiza Elementary school for early voting prior to the election day. ®

In addition to the personal-contact “street cons” perpetrated upon senior citizens and others by professional con-artists, telephone and mail fraud and cons have expanded rapidly.

Further, fraud efforts communicated through computer networks are now becoming common.

Effective December 31, 1995, the Federal Trade Commission has implemented a stronger set of regulation to control telephone fraud. State attorneys general can seek a nation-wide injunction against a company.

Telemarketers are not allowed to call you before 8 a.m. and after 9 p.m. Telemarketers must tell consumers at the beginning of a call that this is a sales call, the nature of the product or service being offered and, in the case of a prize promotion, that no purchase is necessary to win.

Before asking consumers for money, telemarketers must disclose cost and other information, like the terms and conditions of a refund. In the case of prize contests, the odds of winning must be disclosed and for investments, risk and profitability. Telemarketers cannot debit a caller’s checking account unless they have received written approval or a taped authorization.

## Environmental Committee

### Pruning Simplified

Information for this article was provided courtesy of Ronland Nursery, Inc.

**Rule #1:** Prune when the plant is dormant (January, February). Pruning sealer is a good idea on cuts larger than an inch.

**Exception to rule #1:** Spring-flowering shrubs (lilac, forsythia, and the like) should be pruned immediately after bloom. Because these shrubs bloom on the *previous* season’s growth, pruning in winter would cut off the upcoming flowers.

**Rule #2:** Prune to thin and shape. Cut out dead wood and branches that cross and rub against another and branches that grow back toward the center of the plant. This lets in sunlight and allows air to circulate freely.

**Exception to rule #2:** Prune fruits and berries for highest yield. Thin out deadwood, crossing and inward growing branches as above. Ask your nurseryman or extension agent about



the idiosyncrasies of different fruits and berries. For example, raspberries produce only on year-old canes, which should be cut to the ground right after fruiting.

**Rule #3:** Choose the direction of the new growth. By making your cut above a bud that faces the direction you want the new growth to go, you can further shape the plant just as you want. Be patient though... these things take time.

unfavorably. That, plus employ our own teenagers in the summer to maintain the fence-to-street areas along those same streets. - *Kay Admire*

A: Although this is an ideal goal, there is no money for such a "big one" project. The City has no money and TRNA has no money for this type of thing. Providing a new coat of paint or stucco for entire lengths of the street would be quite costly. Once builders move out of the area, it is the duty of the neighbors to provide upkeep for their wall and the curb-to-sidewalk area behind their wall when it faces a street. The city provides a graffiti hotline to have the mess covered. TRNA also has volunteers that aggressively cover up graffiti. If a solution comes to mind, please contact a TRNA board member.

Q: This is a big one. Could there be some sort of task force to look at painting (restuccoing?) all of the backyard walls that face the main streets like Montañó, Dellyne, Golden, Valle Vista and others?

It would be ideal if they could all start out as one basic brown color and then when the graffiti bandits trash them, covering them over would be so simple having one dye lot of paint. If you are a new comer to the neighborhood (or a prospective buyer) it is unsightly, and presents our nice neighborhood

I am a member of TRNA. I was very distraught in reading the November 1995 issue of the Mesa Messenger. I am a parent of three little leaguers in Petroglyph Little League and also a Board of Member (sic) of Petroglyph Little League. I attended the Board meeting regarding Mariposa Basin Park and left with the understanding that the City would await community input before making any determinations regarding the basketball and volleyball court or an additional baseball field. However, unlike the City, your organization took it upon itself to decide for the rest of the community to oppose the addition of another little league field.

It is my understanding that TRNA is a neighborhood association which operates for the benefit of our community. I was unaware that two or three people comprising your board would act as dictators to tell the neighborhood what they want without any input from the community. Due to your irresponsible act in opposition of little league fields, you have basically cut

**Other information about the issue as provided by the TRNA Board:**

- ◆ For any changes to the current approved development plan, the City must notify surrounding homeowners, give them the opportunity for input and have each of them approve all changes to the development plan. The original sessions with surrounding homeowners began in 1989. Changes for more little league fields would start this process again and cause more delays to take place.
- ◆ The City originally planned to put an adult softball complex in the park. It was TRNA and the surrounding neighbors who fought to have the Basin become a Little League field.

off 250 families from participating in a summer sport that keeps our kids off the street. Due to your unilateral act, 250 children will not be able to play little league next year. Instead, we will have basketball courts that no one will utilize just like the horseshoe pits as well as a volleyball court. Shall I send you the names and addresses of the 250 families and children you will disappoint, so you can explain to them why their input was not considered or even requested?

I am not complaining as to the results of your decision, but terribly disappointed on the mechanics or lack thereof, for making the decision. If you had received community input in opposition to the addition of three little league field (sic), I would not complain because the result would have been from the community.

When I joined your organization, I thought it was to benefit the community but not benefit a chosen few. Therefore, I hereby resign as a member from the TRNA, Inc. and will encourage others to do so as well, and hopefully someone someday can form an organization that will speak for the community instead of for themselves. As my last act as a member of your organization, I request that this letter be placed in your next newsletter. However, after seeing how your

organization operates, I sincerely doubt that it will be done.

## TRNA President's Response

January 12, 1996

Dear Mr. Armijo,

I was very sorry to receive your letter dated November 20, 1995, expressing your displeasure with the TRNA Board's recommendation to the City to proceed with Phase 3 of Mariposa Basin Park as planned.

As you recall, TRNA's board was instrumental in obtaining \$25,000 from Smith's to compensate Petroglyph Little League for the construction costs caused by Smith's building sooner than expected on the site where parents had constructed fields. We have supported shared use of soccer/baseball fields at public parks. We continue to be supportive of Little League fields in the neighborhood. We would be happy to work with you to identify and acquire space for additional little league fields. Some board members are of the opinion that there might be space available at or near Chamiza Elementary.

As to the need to solicit community input before making our recommendation, there have been many public meetings held over the years during Phase 1, 2, and in preparation for Phase 3 of the Mariposa Basin Park. During these meetings we have heard parents express the need for soccer fields, baseball fields, playgrounds, space for informal activity, and safe parking for large events such as concerts. Also, over the years, there have been complaints that the City is spending the money allocated for Mariposa Basin Park on planning activities rather than building. A recommendation to stop the

construction and go back for additional input would have resulted in spending still more of the Park funds on planning activities.

As a result of this past public input, out of a desire to be fair to elements of the community who desire space for other activities, and in the hope that planning would stop and building would start, the eleven members of the board voted to recommend to the City that Phase 3 be completed as planned.

I am sorry that you have canceled your membership. I will forward your cancellation to your membership chair to see if we owe you a refund of dues. I will also consult the Board about printing your letter in our next newsletter. I believe we would want to print our reply as well, and that might take too much space. We may simply summarize the controversy.

I hope you will reconsider and rejoin the Association. I believe we can accomplish much more work together than we can separately.
