Unification Charter Commission

As you may have noticed, when the Commission began work in March, there was very little publicity about the work being done. The newspapers and radio/TV stations didn't seem very interested. This has changed since the Commission hired contractors to provide information to the public. Newspaper coverage has improved and the first public forum, held in June, provided an opportunity to better inform the public. A second forum will be held on August 8th, location still to be determined.

All meetings of the Commission are open to the public. Working meeting are held in the City Council Chambers, basement of the City/County building at 5th and Marquette, every other Friday from 4:00 – 7:00. To supplement this schedule, a few Monday afternoon meetings, from 2:00 – 5:00, have also been scheduled. A few of these working meetings will be relocated to community venues, at the request of those attending the first public forum

At the public forum, most of the time will be dedicated to hearing public comment. At working meetings the public may comment briefly at the beginning of the session, and again at the end, if time permits.

Dear Neighbors and Friends:

I dropped in at the TRNA flea market last month and enjoyed seeing many neighbors at the event. One question did come up while I was there that I thought would be worth putting in the newsletter.



The question was regarding abandoned vehicles. The Westside currently has the most reported abandoned vehicles of any of the police area commands in the city. So needless to say they keep us pretty busy. If anyone wishes to report an abandoned vehicle either on public or private property they should call the new 768-CARS number to report the vehicle. That information is forwarded to my office and it is then assigned. Abandoned vehicles on private property are processed through a different unit in our department.

Sometimes owners of what looks to be an abandoned vehicle will be made aware of the complaint and will move the vehicle temporarily. If a vehicle is drivable it normally isn't considered abandoned. Also just because the vehicle is old or UGLY, that isn't considered abandoned either, as much as some would like it to be.

If you have reported a vehicle abandoned and want to know the status of your complaint, you can call me. My new office number is 831-4705 and I will look up the information for you. Stay safe, ~ Ed☀

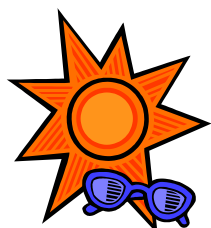
