# **Land Use Update**

The Environmental Planning Commission (EPC) approved the Hoffmantown West Church Project and the Montano & Winterhaven Shops Project at it's December 16, 2004 meeting. Both projects were approved with conditions, some of which were requested by TRNA. Also at the December 16 meeting the EPC voted to accept the withdrawal of the Eagle Ranch Road Project. This project was to change the zoning from residential to commercial.

TRNA has been notified of a project proposed for the northwest corner of Paseo del Norte and Eagle Ranch Road. The proposed project includes retail stores, office buildings, and service establishments such as banking, restaurants, hotel, and residential condominiums in high rise buildings. Two facilitated meetings have been scheduled to present the project to the neighborhood and to introduce the development team. The meetings will be held at Petroglyph Elementary School on January 10 and 24 at 7:00 PM. ...continued on page 5.

# From the desk of **Lieutenant Edmond Perea**

Dear Friends,

In assuring that you have a safe and healthy holiday I want to remind you that this is the time of year when frost often covers our vehicle windshields. When we're running late and we really don't have the time to deal with the task of scraping the ice off, some of us might be tempted to chance it and jump into our car before the ice on the windshield is completely defrosted. We then turn our vehicle defrost switch on high and hope the ice on the windshield melts away before anyone notices. This can create unsafe situations.

So for your safety, as well as others, take a few extra minutes to scrape the ice off your windows before you drive off in your vehicle. Police officers investigate many accidents where a driver attempts to drive a vehicle before the car windows are completely defrosted. It is important that all windows are clear before you drive your vehicle. This might sound a little obvious but invariably I see some individuals driving on our streets with a little hole cleared out for them to peek through while on the road. Sometimes these drivers don't make their next destination in one piece and that goes for their cars too.

Another potential problem we can create for ourselves on these cold winter mornings is when we leave our cars unattended and running outside our homes waiting for the car to warm up. Officers investigate, virtually on a daily basis, reports of stolen vehicles where owners have left their vehicles unattended and running while they wait for their car to warm. No area of town is immune from these thieves. These thefts happen at anytime. The lengths that criminals will go to in order to commit a crime is amazing, but

> believe me they're out there just waiting for their next victim. I care about you and want you to give yourself a little extra time in the mornings. Be aware of your surroundings and be safe.

## **Country Living in the City**

I wrote this article for the *Coalition of Albuquerque Neighborhoods Newsletter* over 20 years ago. It was also published in our *TRNA Newsletter* in August 1983. It emphasizes the need for a strong neighborhood, which is still true today.

#### Country Living in the City

"Oh, what a view"... With that picture in mind, many of the present Taylor Ranch people bought a piece of the Golf course, equestrian center, single family homes... all too good to be true. Bulldozers and moving vans met each others on the dangerous Coors Road and the unpaved Dellyne. But things started changing. The master plan had to be revised: the developer proposed smaller lots, apartment buildings, a six lane highway that would cut Taylor Ranch in two (running next to the power lines), a shopping center the size of Winrock/Coronado combined, and out with the equestrian center and the golf course. It became a matter of money: what could the developer squeeze out of the land (we can't blame them; they are in business to make money) and how could the developee keep up the value of his home?

Against this background the Taylor Ranch Neighborhood Association was born. I believe we have one of the finest associations in town: maybe not in quantity but certainly in quality. We may not always agree among each other (an example below), but we have successfully made deals (what politics is all about). We do not have a six lane highway through the middle of Taylor Ranch, we will have a sized down shopping center, we have a small park, we have a dust ordinance (recently acquired), and we still have an equestrian center. In our dealing with other organizations, developers, or the city, the Board tries to keep in mind that it is not a choice between good and evil, but between two goods and that it is better to compromise than to antagonize.

Now we have the bridge issue. In our June [1983], newsletter we asked people to answer the following question: "Do you favor a bridge at Montano?" 46 said yes, 7 no, and 6 preferred a bridge at El Pueblo. The circulation of the questionnaire was approximately 1100 homes during June and July. Assuming that two people per household could have read the question, approximately 2200 people could have answered. Only 59 did. A 2.5 % response is hardly overwhelming. The Board members themselves are split on the issue and the response to our survey,

although strongly preferring a bridge at Montano, wasn't a large enough number for us to be able to say: "the residents of Taylor Ranch want a bridge at Montano"

There are good arguments for and against a bridge at Montano: "The bridge at Montano is the cheapest." That is a good point. "Why bring half of Rio Rancho down Coors past Paradise Hills before they can cross the river?" That's a good point too.

When all the committees' and subcommittees' work is done, when the politicians find the issue no longer attractive, when the traffic becomes so overpoweringly messed up, the bridges (wherever they may be) will come. In the meantime give us something that is politically attractive to solve the traffic problems: more buses, a lane for share-a-ride, or widening the entrance to I-40 East at Coors.

General Patton ordered parts for his tanks from the Sears Catalog. He was a manager. He could have waited; he didn't. He chose to solve the problem.

About half of these have links to web sites, some with forms you can fill out online. For instance you can now do these things online with the city:

- ◆ Report a street pothole for the city to fix
- ◆ Report graffiti for the city to paint over
- ◆ Report an abandoned vehicle to be removed

Reporting these online may save some time on the phone, not to mention keeping your neighborhood in shape.

If the information in this newsletter doesn't satisfy your civic appetite, you should try the link to Albuquerque's Office of Neighborhood Coordination's newsletter "Neighborhood News." In the past each neighborhood association received a copy; however, you can now access all the information yourselves online.

Did you know that last year Albuquerque started providing free wireless Internet access at various hotspots in Albuquerque? Our Taylor Ranch Library is one location. Others include Civic Plaza and the Sunport. Check out http://www.cabq.gov/wifi/ for more locations.

# **Nearby Taylor Ranch**

Recent Developments within and nearby Taylor Ranch

In December, the Albuquerque Biological Park announced the opening of the greatly-anticipated Africa exhibit area at the Rio Grande Zoo. The new section of the zoo comprises six acres of land, 17 separate exhibits and 23 species of mammals and birds.

"Thunderbird Express," a three-quarter scale train sponsored by Sandia National Laboratories and Lockheed-Martin Corporation, runs in a loop through the zoo from 10am to 3:30pm daily at 20 minute intervals. Train tickets are \$2 for adults and \$1 for children and may be purchased at the Out of Africa gift shop.

Digital Fine Art Society of NM presents Digital Albuquerque at the Kimo in January and February. New on the art scene, this unique expression of the high-tech times we live in is fast making a foothold in the fine art world.

Every Monday except holidays, Explora opens an hour early just for toddlers and their adult companions. Join Explora staff in the KneeHiSci area and the theater for exploration and play designed just for toddlers. For the older crowd, starting Mon., Jan. 10, 4:00-5:30pm, ESI: Explora Science Investigators is Explora's new semesterlong science club for 4th - 8th graders.

Pre-registration is required. Call 224-8341 to find out how to participate in this after-school exploration of various science concepts.

At our own TR Library, "Storytime for Toddlers," 18-36 months, with an adult, on Tuesdays, 11-11:20 am, starts Jan. 11 through April 2005. Each session consists of picture book stories, nursery rhymes, fingerplays, flannelboard stories, music and/or action activities geared toward this young audience. No registration is required.

"Storytime for Preschoolers," 3-5 years is on Wednesdays 10:30-11:10 am, starting Jan. 12 through April 2005. These forty minute sessions consist of 3 to 4 stories and activities developed for the preschool audience. No registration is required.

The Environmental Planning Commission (EPC) conditionally approved the Village Inn Site Development Plan for approximately 2.85 acres on the northern most lot of the SE corner of La Orilla and Coors Rd. Conditions of approval included major upgrade of proposed landscape plan to include 75% coverage of xeriscape plants, living ground cover, with gravel being used as accent and gap fillers only. The Village Inn agent agreed that the landscaping would be maintained. Other conditions included bike lanes, widening of Coors landscaped area to provide for public use, non-invasive parking lot lighting and other road and access agreements. Access to the restaurant will be along Bosque Plaza Loop Road via La Orilla Road." ®
