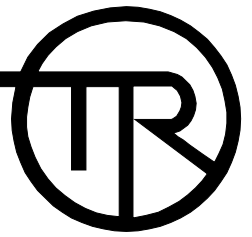

West Side Coalition of Neighborhood Assoc.'s Meeting—March 7, 2007

The District Attorney's Office and the Police Department reported and requested citizen's help in eliminating crime and DWIs in Albuquerque. Most crime is created by repeat offenders, 80%. Many of these offenders are career criminals, and the DWIs are also repeat offenders. The question is why are they still operating ?

The APD and the DAs office are doing their job, and very

efficiently, so seems like it is a breakdown in the judicial system, where the judges seem to feel sorry for the offenders rather than the offended, and they slap the offenders on the wrist, rather than putting them where they can't hurt someone. Both problems can be solved by court watchers, and any citizen can be a court watcher by contacting Bill Hoch of the DAs Office. They can call Bill Hoch at 841-7114 for more information. Something has to be done. Albuquerque is one of the worst areas in these offenses in the country.

Here is an example of the revolving door justice system that we as citizens and police officers alike face. An active criminal on the WestSide, lets call him John Doe, has the following record: 3/ 5/ 07 Agg. assault. poss. of firearm - 1/ 30/ 07 drugs, stolen property - 7/ 4/ 06 Agg. assault w/ deadly weapon - 7/ 4/ 05 Prob. violation - 1/ 14/ 05 parole violation - 7/ 23/ 97 Res. burglary - 12/ 4/ 95 Agg. burglary - 6/ 30/ 95 DWI - 7/ 3/ 93 Agg. burglary - 5/ 23/ 93 Res. burglary, Larceny - 3/ 16/ 93 Res. burglary - 8/ 13/ 91 Agg. burglary, stolen firearm, possessing of firearm, larceny, resisting arrest etc. - 7/ 2/ 91 Agg. Res. burglary - 9/ 20/ 90 Res. burglary - 8/ 8/ 89 DWI - 4/ 11/ 89 Res. burglary - 2/ 22/ 84 CSP, kidnapping - 2/ 16/ 82 Grand larceny. **In total, arrested 18 times in 25 years** . In the past 30 days police have made 25 criminal arrests. Rehabilitation, you have to be kidding. This is why citizens have to become involved as court watchers.

A joint APS and YMCA program has been approved. A new Y will be built close to the new NW high school, and the students will be able to use the Olympic size pool at the Y. A win-win situation for both the APS and the YMCA.

Land Use Update

René Horvath, Land Use Director, TRNA

1. **County/ La Orilla:** The hearing was scheduled to be heard March27th, but was again deferred for another 30 days. It was mentioned in the last newsletter that the County offered to negotiate. So far what has been discussed, is to move the grocery/ Wal-Mart/ building an extra 10 feet away from the back wall of the Rio Oeste residents who are just south of this site. The architecture would be changed to territorial style. The hours would reflect the same hours as Raley's and Smith's. The location of the loading docks on the eastside of the building facing Coors is a problem that still needs to be addressed. The La Orilla roadway design and alignment issues, still needs to be resolved, but they are not part of the negotiation. If things are agreed upon, then the County wants TRNA to drop the replat appeal. The next hearing date will most likely be **April 24th** before the **County Commissioners**. If you have any comments or questions about this issue, please call me.

2. **Andalucia:** Deferred again until **May 17**. There is nothing new to report, but this is still an important issue.

3. **Coors Corridor Plan:** The new plan, is scheduled to be heard **April 12th**, by the **EPC**. There are unresolved issues that need to be addressed such as the view regulations. I have not heard anything new from the City yet. It is very critical that these issues get resolved and that this plan is evaluated carefully before it's approved. If you have any time to give this project and are interested in the outcome of this plan please give me a call.

4. **Oxbow Town Center:** This project was presented to the Westside Coalition at the start of the year. There was one facilitated meeting since then. The project consists of 47 acres on the west side of Coors, across the street from St. Pius. There are two parts to this project. The southern half of the project will be a shopping center. The northern half will be a big office complex. The shopping Center portion of the project, is scheduled to be heard **April 12th**, by the **EPC**. There is no known opposition. Any comments from TRNA will likely focus on details such as design, lighting, signage, etc.

5. **Lee's Bosque Subdivision:** 6.82 acres located on the eastside of Coors Blvd., just north of Bosque Meadows subdivision. The owner would like to change the zoning from RD to SU-1 for C-1 (commercial) uses. A second facilitated meeting was held March 20. People from Bosque Meadows, Coors Trails, and TRNA were there to participate. RD zoning was originally thought to allow 85% residential, and 15% commercial. But as it turns out that in this case the only choice would be to keep residential or change the zoning to allow commercial. A majority of the people at the meeting did not want the zone change. **The EPC Hearing** is set for **March 19**.

As it turns out the next few months will be very busy. There are five projects that need to be addressed. They are all along Coors Blvd. If you interested in any of these projects please let me know. René Horvath 898-2114 or land@trna.org ☺
