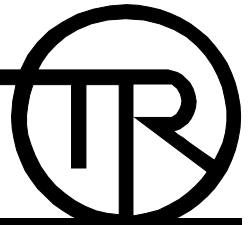

## Land Use Update

**1) Volcano Heights EPC hearing September 2<sup>nd</sup>:** The original Volcano Heights Plan was adopted by the City Council in 2006, but was appealed to district court by the Volcano Cliffs property owners. The court remanded the plan back to the City for two reasons: 1) The plan needed to have an air quality analysis done for the area; 2) The development review of the 2006 plan did not follow the proper process.

The City has since revised the 2006 Plan. It is now called the Volcano Mesa Plan. It covers 3,532 acres of the mesa top. It is divided into three sector development plans: (1) Volcano Cliffs Sector Development Plan: where lots are individually owned by the Volcano Cliff property owners, located immediately above Taylor Ranch. (2) Volcano Heights Sector Development Plan: a mixed-use urban town center to provide approximately 20,000 jobs, at Unser and Paseo del Norte. (3) Volcano Trails sector plan: primarily a residential development with mixed densities and some commercial, located north of the three APS schools west of Universe Blvd. The projected population for the Volcano Mesa area, including Ventana Ranch and

Quail Ranch will be 107,000: 30,000 in the Volcano Mesa area, 75,000 for the Quail and Ventana Ranch areas.

The three plans are based on the original 2006 plan, but tailored to the goals and vision of the affected stake holders and property owners from each plan area. TRNA was involved in the 2006 Volcano Heights Plan. TRNA supported the preservation aspect of the 2006 plan. This included sensitive development around natural features, and preservation of buffer areas to protect the escarpment, arroyos, and view areas. TRNA also had concerns about traffic and drainage.

Changes made to the 2006 plan include elimination of the open space buffer along the escarpment and arroyos, and other natural features. When we inquired why the open space buffers were taken out, the reply was because Open Space has no money. These modifications of the 2006 plan benefit the property owners but the citizens of Albuquerque lose out. Members from TRNA have been trying to get the open space put back into the plan. TRNA is also concerned about the amount of traffic coming from the planned area which will have a huge impact on the Taylor Ranch area and our river crossings. The EPC will hold two public hearings to review the Volcano Mesa Plan. The first one is at **3:30 PM on Thursday September 2<sup>nd</sup> in the hearing room of the Planning department** at Plaza Del Sol, 600 2<sup>nd</sup> street. Give me a call if you would like to carpool or need further instruction to get there. We need people to go to the hearing.

**2) MRCOG transportation meeting with TRNA, August 19<sup>th</sup>:** The TRNA Board was interested in knowing more about the future traffic situation for the Taylor Ranch area. MRCOG (Mid Region Council of Governments) offered to do a presentation on August 19<sup>th</sup>, for TRNA on the Long Range Transportation Planning focusing on the Northwest region, which includes Rio Rancho. A meeting was quickly arranged for August 19<sup>th</sup>, at the Taylor Ranch Community Center. Three representatives from MRCOG gave the presentation. Members from TRNA, Sante Fe Village, and Sarah Westbrook from Councilor Lewis's office, attended the meeting. It turned out to be a very informative two hour presentation.

There are no plans to build new bridges. Bridges cost more and are more controversial to build than a transit system. Jurisdictions on either side of the river have not been interested in building a bridge in their communities. The focus is now on developing a Bus Rapid Transit (BRT) system that uses buses on specifically dedicated

lanes for quick travel time and rapid service.

One system, known as the BRT Guide-way System is being considered. It is used in other Countries. Regular buses can travel on special guide-way lanes, using a curb barrier to separate it from regular traffic. These buses can also travel on regular traffic lanes. MRCOG is thinking of locating the first BRT guideway system along Paseo from Unser to the Journal Center. A study is exploring this option.

The cost for something like the BRT is approximately \$50-75 million. In comparison, the Rail runner cost \$350 million to expand from Belen to Santa Fe, covering a much bigger service area. The proposed Paseo/ Jefferson I-25 interchange will cost approximately \$390 million to build, for just the interchange alone. In 2008, the voters supported a 1/ 8% gross receipt tax which formed the Rio Metro district. One half goes to the Rail Runner and the other half goes into Transit. Federal money is also used for roadways and transit facilities. Impact fees are used for roadways and trails. MRCOG said land use planning and transportation planning need to work together. Better policies on land use need to be put in place. Portland Oregon has tightened their control over land use planning, in order to develop a quality transit system for the city.

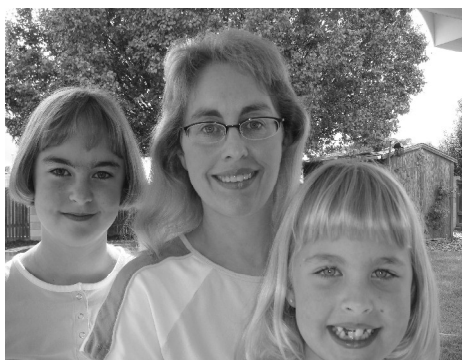
In order for the Volcano Heights plan to work, job creation and a BRT system will need to be in place. When asked why most of the job growth is still on the eastside of the river, MRCOG representatives thought perhaps it was because businesses want to locate where there is easy access to other companies and services. It is apparent to us that our existing roadways and river crossings are not capable of supporting any more growth.

**3. Impact Fee moratorium extension – City Council:** On August 16<sup>th</sup> City Council voted to approve the extension of the moratorium for the Impact fees. Two City Councilors did not support the extension, Councilor O’Malley, and Councilor Garduño. They said the Impact fees are necessary. Councilor Lewis and Councilor Trudy Jones sponsored the legislation to extend the moratorium for 12 months. Councilor Sanchez introduced an amendment to extend the moratorium for only for 6 months. The 6 month moratorium barely passed. The Chamber of Commerce, Home Builders, and members from the development community were there to support the moratorium. They said that the moratorium has helped the local economy with an increase in residential building permits which would provide gross receipt tax for the City. Three members of the League of Women Voters, three members on the TRNA Board, and Susan Johnson (who initially worked on the impacts fees) were

there to oppose the extension of the Moratorium. The League of Women Voters said that the impact fees have helped the community keep up with needed infrastructure and services. TRNA said that the development industry needs to pay their fair share otherwise the taxpayers are subsidizing the development. TRNA also brought up that the revised Volcano Heights plan lacks funding for open space. The City's impact fee implementation plan included impact fee funding to be used for Open Space, and drainage projects for the Volcano Mesa area. Also, the Capital Improvement projects will receive less funding this coming year, than in years past. This means even less money generated for open space, parks, trails, public safety, road projects, and drainage.

The City Councilors brought up that the City hired a Consultant to review the impact fee program. Some Councilors feel that the impact fees are too high, especially for the west side, and would like to see an overhaul of the impact fee system to make the fees more the same across the city. They say that the fees hinder growth on the Westside. The Financial analyst for the city said that even though there was some housing growth on the Westside, it was inconclusive whether it was due to the impact fee moratorium or other factors that were used to stimulate the economy. Note: the City is divided into different

service areas. Each service area has different infrastructure needs. The Westside has more infrastructure needs than older existing areas of town, therefore the impact fee are higher on the Westside to cover the costs. These fees cannot be transferred to other service areas except for open space and public safety. In 2004, the City hired professional Consultants to develop the impact fee system for the Albuquerque. Many Cities around the Country are using impact fees. The Business community, City department staff, and the Citizens of Albuquerque all participated to develop the current impact fee system. The current fee system may need tweaking to improve it, but not an overhaul. We will be hearing more about the impact fees in 6 months when the moratorium expires. Some Councilors said they would be willing to extend it another 6 months if necessary to jumpstart the housing/commercial development on the Westside. I find this very interesting especially when we don't have a transportation network to support any more growth on the Westside, or funds to buy open space before it is developed.

**4. The Fly Way Art Project for the Open Space Visitor Center:** City Council voted 5 to 4 to keep the funding for the "Fly Way" art project. There was a lot of discussion, by the City Councilors in regards to this project. Should this project be funded with the current problems the City is having with the general operating budget? Councilor Lewis felt it should not. Other Councilors felt that since the funding comes from the capital improvements budget, which is approved by the Albuquerque voters, then it should be used for what it was intended for. If the money is not used for the "Fly Way" then it will be used for another art project somewhere else in Albuquerque. Funding for Art cannot be transferred to the general operation budget. It also cannot be transferred to pay for repainting the Montano bridge tiles, which was another idea that came up. Several City Councilors said that art is subjective and not everyone likes every art project. They have had similar situations in their own districts. They rely on the selection committee which is made up of volunteers to select the art project. In this case the "Fly Way" met all the criteria the selection committee was looking for. One Councilor brought up that even the Vietnam Memorial had opposition in the beginning. Today it is an extremely popular Memorial. ®

From June 15th through August 19th (2010), Taylor Ranch residents made 677 calls for service to APD (that’s about 10 per day.). Of those 677, 205 were traffic related calls! (That reminds me, be careful driving in the neighborhood. School is in session.) 109 calls concerned assaults, 75 burglaries, 59 thefts, 45 vandalism, 12 stolen vehicles, 8 forgery, 5 sex offenses, 3 robbery, and 127 lumped into “all others”. While we’re not the most crime-ridden community in Albuquerque, se have a long way to go to make ourselves crime free.

Most auto burglaries are reported on Fridays around 7 pm and as are most residential burglaries, between 2 and 5 pm. Again, of the 12 stolen vehicles, four were reported on Friday around 11 am.

On our patrols we see it all the time: open garage doors (bicycles, tools in clear view), cars with open windows (sometimes with engines running), open access to the backyard and obstructed views of front doors. All this presents opportunities to criminals.

A little prevention can do a lot! Remember, if you give the thieves an opportunity, it is not **if**, but **when** you will be the next victim.
